GYM N'SWIM

Sign your toddler up (3 & 4 years) for this combination class that focuses on the fundamentals of movement using kinder gymnastics and basic swim skills. Start with 30 minutes of kinder gym instructor-led activities focused on improving balance, flexibility and confidence followed by a 30 minute basic swim lesson.

The kinder gym portion of the class will utilize basic equipment such as mats, even bar, hoola hoops and more. When in the pool your child will learn basic swim skills, water safety and confidence while in the water.

Each session consists of 8 classes. Classes are available on Monday & Wednesday or Tuesday and Thursday from 11:00 am - 12:00 pm.
